Every entrant at any ISR/Oldenburg NA stallion, mare and foal inspection shall constitute, by written signature where indicated below, this agreement affirming that the person making said entry and those participating with that person, i. e., owners, handlers, trainers, grooms, or other attendants, and the horse or horses attending said inspection shall: 1) be subject to the corporate bylaws and the rules and regulations of ISR/Oldenburg NA, regardless of membership status; 2) accept the final decision of the ISR/Oldenburg NA appointed evaluators on any issue and/or question arising from participating in this inspection; 3) further agree to hold harmless the ISR/Oldenburg NA, their directors, sponsors, inspection hosts, agents, employees, and all other personnel for any and all injuries or loss involving persons, horses, or property, whether or not such injury resulted directly or indirectly from the acts or omissions of said evaluators, directors, sponsors, event hosts, agents, employees, or other personnel acting on behalf of ISR/Oldenburg NA. The term "inspection hosts" shall specifically include the owners, managers, agents, employees, or other personnel acting on behalf of the inspection host and all immediate family members as well as all persons employed or engaged by the inspection hosts and/or co-hosts to assist in the logistics and the conduct of the inspection and the branding of foals.
